The Policy Board met on Thursday, July 13, 2017 1:30 p.m., SIMPCO, 1122 Pierce Street, Sioux City, Iowa. A quorum was present. *Chair Beaulieu called the meeting to order at 1:30 p.m.*

- I. **Pledge of Alliance & Introductions:** Chair Beaulieu led members in the Pledge of Allegiance and introductions of members, staff, and guests.
- II. **Approval of the Agenda:** Chair Beaulieu asked if there were any additions or corrections to the July 13, 2017 agenda as presented.

*Craig Anderson moved to approve the agenda as presented, seconded by Dan Moore. Motion carried all ayes.*

- III. **Approval of the Minutes:** Chair Beaulieu asked if there were any corrections to the April 27, 2017 minutes as presented.

*Craig Anderson moved to approve the minutes as presented, seconded by Richard Owens. Motion carried all ayes.*

- IV. **Review Monthly Correspondence:** Michelle presented pertinent correspondence since the April 27, 2017 Policy Board meeting.

- V. **Transportation Improvement Progress Report:** Iowa Department of Transportation and member cities and counties updated the Policy Board on the progress of transportation improvements throughout the MPO region.

- VI. **Resolution 2018-1 Approval of 2040 Long Range Transportation Plan Amendments:** Michelle presented the following amendments to the 2040 Long Range Transportation Plan:

1. Military Road from Riverside Blvd to Big Sioux River in Sioux City needs to be programmed for a total estimated cost of \$5,800,000 with \$1,325,000 in Federal participation in FY 2018.
2. South Lewis Blvd from Singing Hills to city limits in Sioux City needs to be programmed for a total estimated cost of \$2,769,000 with \$1,930,000 in Federal participation in FY 2030-2040 time range.
3. Tables B.2: *Population and Housing Summary by Jurisdiction and Year as Distributed into the Model* and Table B.3: *Employment Summary by Jurisdiction and Year as Distributed into the Model* needs to be updated to reflect updated projections in the Transportation Model.
4. Maps 5.3 – 5.7 *Level of Service, 2010 to 2040 Forecast Year* needs to be updated to reflect changes in level of service road up to forecast year 2040.

*Dan Moore moved to approve the 2040 LRTP amendments as presented, seconded by Craig Anderson. Motion carried all ayes.*

- VII. **Resolution 2018-2 Approval of the FY 2018-2021 MPO Transportation Improvement Program (TIP):** Michelle presented the final FY 2018-2021 TIP. She noted there were no comments received back from the public comment period.

*Dan Moore moved to approve the Resolution as presented, seconded by Bill Gaukel. Motion carried all ayes.*

- VIII. **Resolution 2018-3 Self-Certification of the MPO Transportation Planning Process:** Michelle explained this resolution certifies that the planning process in the Sioux

City Metropolitan Planning Area is being carried on in conformance with all applicable Federal requirements.

*Bill Gaukel moved to approve the Resolution as presented, seconded by Craig Anderson. Motion carried all ayes.*

- IX. **Resolution 2018-4 Project Development Sioux City Transit System:** Michelle explained this resolution certifies that the City of Sioux City/Transit System has fulfilled their planning obligations in the development of the TIP.

*Richard Owens moved to approve the Resolution as presented, seconded by Dan Moore. Motion carried all ayes.*

- X. **Resolution 2018-5 Certification of Compliance: Statement of Financial Capacity Analysis:** Michelle explained this resolution certifies that the MPO Transportation Improvement Program FY 2018-2021 for the Sioux City Metropolitan Area is prepared in accordance with the requirement of the Federal Transit Administration (FTA).

*Dan Moore moved to approve the Resolution as presented, seconded by Richard Owens. Motion carried all ayes.*

- XI. **Resolution 2018-6 MPO Targets for Transit Asset Management (TAM) Performance Measures:** Michelle explained this resolution sets the TAM State of Good Repair Performance Target for Sioux City Transit System.

*Dan Moore moved to approve the Resolution as presented, seconded by Bill Gaukel. Motion carried all ayes.*

- XII. **MPO Performance Measures:** Michelle asked the Policy Board to vote on the approach to set FAST Act Performance Measures for the SIMPCO MPO. Discussion followed. Michelle noted the TTC voted on option 1: The SIMPCO MPO could adopt Iowa, Nebraska and South Dakota performance measures.

*Dan Moore moved to approve Option 1, seconded by Bill Gaukel. Motion carried all ayes.*
