

A M E N D M E N T 2 :

Amendment 2 details one addition to the 2045 Long Range Transportation Plan. The amendment was open for a 30-day public comment starting on June 1, 2022, with final review and approval on July 7, 2022, at the SIMPCO MPO Policy Board meeting.

The following is the amendment:

1. West 29th Street (Old Highway 20) reconstruction from Daniels Lane in South Sioux City, Nebraska to Highway 20 in Dakota County, Nebraska needs to be programmed for a total estimated cost of \$11,534,590 with \$9,227,672 Federal participation.

SIMPCO MPO Resolution 2023 – 5

A RESOLUTION AMENDING THE 2045 LONG RANGE TRANSPORTATION PLAN FOR THE SIOUXLAND INTERSTATE METROPOLITAN PLANNING COUNCIL (SIMPCO) METROPOLITAN PLANNING ORGANIZATION

WHEREAS The Siouxland Interstate Metropolitan Planning Council (SIMPCO) is designated as the Metropolitan Planning Organization (MPO) for the Sioux City Urbanized Area; and

WHEREAS, a Long Range Transportation Plan (LRTP) is required by the U.S. Department of Transportation (DOT) and was developed by the MPO for the Sioux City metropolitan area; and

WHEREAS The SIMPCO MPO 2045 Long Range Transportation plan was approved by the MPO Policy Board on January 7, 2021. This plan provides a comprehensive plan to guide multimodal transportation improvements in the Sioux City metropolitan area over a 25-year planning horizon; and

WHEREAS, the city of South Sioux City, Nebraska is committed to the development of transportation infrastructure in their community; and

WHEREAS, the amendment has been made available for public comment for a thirty (30) day period and has been reviewed and recommended for adoption by the MPO Transportation Technical Committee (TTC), and now requires official approval by the MPO Policy Board; and

NOW, THEREFORE BE IT RESOLVED, that the Policy Board of the SIMPCO Metropolitan Planning Organization approves and adopts the amendment to the MPO 2045 Long Range Transportation Planning adding West 29th Street reconstruction to the illustrative projects list.
