The WICIRHTF Board of Directors met on Thursday, May 25, 2023, at 11:15 a.m., via Zoom, and in person in the Meisner Conference Room, 1122 Pierce Street, Sioux City, Iowa. A quorum was present. The meeting was called to order at 11:15 a.m. by Chair Keith Radig.

# 3. Updates -

- a. Housing Manager Report Jenny Anderson, Housing Manager, updated the board on current project and applicant status within the service area of Woodbury, Plymouth, Cherokee, Monona, and Ida counties. Jenny reported 4 projects have been completed since the September 2022 meeting. Jenny also reported that grant 21-LHTF-22 has been completed with 13 homes assisted, grant 22-LHTF-22 is currently open with 9 homes assisted so far, grant 23-LHTF-11 will begin soon with a grant balance of \$380,233. The current housing inspector has retired, and a replacement will be hired to replace him soon.
- b. Josh Bush, Interim Finance Director, presented the board with the housing trust financials through April 30, 2023, noting 83% throughout the fiscal year. Josh reported total revenue YTD at \$437,165 with total expenditures at \$454,288 for a net of -\$17,122.

Devlun Whiteing moved to approve the housing manager report and financials presented, seconded by Gary Horton. Motion carried all ayes.
